We had a drawing for door prizes and everyone took home something.


CLUB NEWS

WOODYISMS

With December drawing to a close we've completed another circle around the Sun on the spaceship called Earth. As I thought about the new year ahead and the celebration associated with the start of the new year, it drew me back to memories of New Year celebrations with my family in Chicago and the Polish traditions as related by my grandparents. On New Year's eve at the stroke of Midnight we ate pickled herring (not my favorite) and washed it down with beet soup (this was always hot and savory). The herring silvery scales denoted money and good fortune according to my immigrant grandparents. On New Year's day we had a large mid-afternoon meal of black eyed peas which represented good fortune or money, Sauerkraut whose long strands represented long life and pork whose rich fat content was supposed to symbolize wealth and prosperity. It seems the Chicago Polish foods associated with the New Year's celebration were thought to represent the wealth, prosperity and long life they hoped for in their newly adopted country.

January is named after Janus, the ancient Roman god of gates and doors symbolizing endings, beginnings, and transitions. He's depicted with two heads: one head looking at the past and the other at the future. We ll do a bit of that as we think about our resolutions for the New Year.

- Jan 1 New Year's Day (national Hangover Day) A federal holiday.
- Jan 16 Martin Luther King Birthday Martin Luther King Jr. Day is a federal holiday. Also called MLK Day, it honors the greatest civil rights activist in American history. His birthday became a National Holiday by an act of Congress in 1983. Many consider it a day to serve your community. Born on January 15, 1929, Martin Luther King Jr. grew to become one of the greatest social activists the world has ever known. He promoted a non-violent civil rights movement. At 35, he became the youngest person to win the Nobel Peace prize. He was assassinated on April 4, 1968, while making a speech from the balcony of his hotel room in Memphis, Tennessee.
- January 22 Chinese New Year 4721 –, Sign: Rabbit, Chinese New Year holiday is celebrated by billions of people around the world. The date of New Year changes every year. It is a 15-day celebration, beginning on the first day of the new moon, and ending on the full moon. This Asian New Year celebration on the 15th day is called the Chinese Lantern Festival. Chinese culture is amongst the oldest in the world. While the rest of the world is in the early years of its third millennium, Chinese culture is in its fifth millennium.

We finished the year with a solid month from a cash flow standpoint. We had income of \$211.00 made up of 50/50 proceeds (Jon Vanatta winner), 2023 dues payments and donations. Our expenses for the month were \$460.00 which was a combined total of \$330.00 from the budget for outings that was used to provide a \$10.00 gift to each member that attended the December meeting and to fund two \$50.00 gift cards as awards for the two members who drove their vehicles the most miles during 2022. Mileage winners were Dee Scott and Pat Schudel. We also paid \$110.00 too AACA for our share of the Liability Insurance premium. As a result we wound up the year with \$4,115.11 in available funds as of 1 January 2023. Typically a non-profit organization is supposed to maintain approximately 2.5 to 3.5 of their annual expenses on hand in their bank account. Our annual expenses average approximately \$1,200.00, so we are well within that goal. Thank you members for your generosity this year in providing \$530.50 in donations to the club.

Our Budget Versus actual for December is the end of the year summary of our budget versus actuals. We did extremely well this year and wound up with a positive variance of \$210.25. We start the new year fiscally strong, but we do have some work to do to get our membership numbers up We lost a few members this year and gained some replacements but our membership remains at 28. So we each need to do our part in recruiting new members.
