WOODYISMS

May 1st-May Day marks the halfway point between the first day of spring and the summer solstice (June 21st this year). This day can be traced back to the days of the Romans as it involved many pagan rituals and ancient customs. These were slowly phased out with the arrival of Christianity, but many festivals, dances, and rituals related to agriculture and fertility were retained, modified to focus on workers and practiced by many European countries. May Day is observed annually on the 1st of May as International Workers' Day. In the USA, it commemorates the sentencing to death of eight anarchist workers in Chicago who were framed for throwing a bomb at police who attacked a strike demonstration in May 1886. The police shat 40 strikers and killed ten of them.

May 14th- Mother's Day seeks to honor and recognize the sacrifices and accomplishments of mothers. Mothers are recognized by family and friends regardless of whether they are biological or perceived maternal figures. This day offers sons, daughters, and anyone with a mother the chance to show their appreciation. Mothers are typically thanked with cards and flowers, breakfast in bed, or by agreeing to do all the household chores. Mother's Day was established in 1914 by US President Woodrow Wilson. It is observed annually on the second Sunday in May.

May 30th_Memorial Day seeks to honor and remember those who died while serving in the military. This day aims to raise awareness about the nation's freedom and the price for that freedom. Every year, U.S soldiers and their families pay that price. Memorial Day is a day for reverence and honoring of those who gave their lives defending the Nation and its values. Congress declared it a national holiday in 1971. It is observed annually on the last Monday of May.

Let's look at the "Cash Flow" Summary Report for May. We had an April income of \$82.50 consisting of proceeds from the 50/50 drawing (won by Erling Onsager), dues payment, donations, and name tag reimbursement payments. Our expenses totaled \$102.50 which consisted of a payment of \$82.50 to Crown Trophy for Name Tags and a \$50.00 donation to the First Coast Car Council for their Spring Car Show. As a result, as of May 1st we have \$4,221.72 available in the checking account.

Our "Budget versus Actuals" Report at this point in our fiscal year is pretty much on target. The bulk of our income is from dues and is generated at the end of the year. It appears at this time that we will achieve our budgeted income. Our expenses are self-determined except for payments for Liability Insurance and our organization registration with the state. I do not anticipate a negative variance in expenses currently. All in all from a fiscal sense, we are in good shape.
